# **PROOF OF DOMICILE**

(Affidavit Forms for Residency D - E - F)

**(Present All Original Documents – Not Copies)**

### **IF YOU ARE THE PARENT AND OWN THE RESIDENCE IN WHICH YOU LIVE, YOU MUST SUBMIT THE FOLLOWING:**

- **Form D (Owner Affidavit)** – completed, signed, and notarized
- Deed for home/property
- Current mortgage statement
- Latest County and School Tax Receipt
- Driver's License

AND **THREE** OF THE FOLLOWING:

- Gas Bill
- Electric Bill
- Water Bill
- Cable Bill
- Telephone Bill
- Moving Company Statement
- Insurance Bill
- Tax Return

### **IF YOU ARE THE PARENT RENTING THE RESIDENCE IN WHICH YOU LIVE, YOU MUST SUBMIT THE FOLLOWING:**

- **Form E (Non-Owner Affidavit)** – completed, signed, and notarized
- Current house or apartment **lease or rental agreement**.
- Owner of the Premises must complete and have notarized **Form F (Owner/Landlord Affidavit)** and must present a **copy of the deed** along with the most recent tax bill for the premises.
- Photo ID
- Driver's License

AND **THREE** OF THE FOLLOWING:

- Gas Bill
- Electric Bill
- Water Bill
- Cable Bill
- Telephone Bill
- Insurance Bill
- Moving Company Statement
- Tax Return

**IF YOU ARE THE PARENT RESIDING WITH A FRIEND OR RELATIVE WHO OWNS OR RENTS THE RESIDENCE WITHIN THE DISTRICT'S BOUNDARIES, YOU MUST SUBMIT THE FOLLOWING:**

- A. If you are a **renter/non-owner, living with the owner of the property**, you must submit the following:
  - a. Completed, notarized **Affidavit of Renter/Non-Owner (Form E)** and
    - i. Lease or rental agreement
    - ii. Three (3) current bills addressed to this residence in the district
    - iii. Driver's license
  - b. Completed, notarized **Owner/Landlord Affidavit (Form F)** and
    - i. Deed
    - ii. Most recent Property Tax Bill or Receipt
  
- B. If you are a **non-owner living with a renter of the property**, you must submit the following:
  - a. Completed, notarized **Affidavit of Renter/Non-Owner (Form E)** and
    - i. Lease or rental agreement
    - ii. Three (3) current bills addressed to this residence in the district
    - iii. Driver's license
  - b. Completed, notarized **Owner/Landlord Affidavit (Form F)** and
    - i. Deed
    - ii. Most recent Property Tax Bill or Receipt
