Past Legislative Efforts

At the direction of the Board, **LAC** has conducted research, engaged in multiple communication campaigns with community members, and initiated many advocacy efforts with state and local representatives regarding:

The Decommissioning of the Power Plant, Unfunded Mandates, Teacher Evaluations/APPR, Charter Schools, Gap Elimination Adjustment (GEA) which as a result of statewide advocacy efforts has been permanently eliminated beginning with the NY State's 2016-2017 budget, Joint Legislative Efforts with Neighboring School Districts, and Hosted Legislative Night at the North Shore Schools, and other meetings with our legislators.
