North Shore Schools Board of Education Regular Meeting Minutes October 6, 2016

The meeting was called to order by President Antoinette Labbate at 6:00 P.M. in the Glenwood Landing Auditorium. Present were Trustees Berliner, Commander, Gonzalez, Jones, Ludmar and Russo. Also present Superintendent Dr. Edward Melnick, and Assistant Superintendent Olivia Buatsi. Assistant Superintendent Rob Chlebicki was absent.

At 6:00 pm on motion of Trustee Jones and seconded by Trustee Ludmar and all in favor, the Board moved to convene an executive session in the Glenwood Landing Principal's Office to discuss matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or persons and collective negotiations pursuant to Article 14 of the Civil Service Law (the Taylor Law).

At 7:30 pm on motion of Trustee Gonzalez and seconded by Trustee Commander and all in favor, the Board moved to come out of executive session and resumed the regular meeting in the auditorium. There were approximately 30 people in the audience.

Pledge of Allegiance

President Labbate led the audience in the Pledge of Allegiance.

Michelle Obama Let's Move Award

Dr. Melnick congratulated the principals of all five schools, as well as Athletic Director Don Lang, & Physical Education Teacher Megan McCormack for receiving the Michelle Obama Let's Move Active School Award. The National Award celebrates a school's outstanding efforts in creating an Active School environment and commitment to integrating physical activity before, during and after the school day. To earn a Let's Move! Active Schools National Award, a school must have met significant benchmarks in five areas: physical education; physical activity before-and after-school; staff involvement and family and community engagement. Each school has received a congratulatory letter from First Lady Michelle Obama and will receive a large display banner. Dr. Melnick acknowledged the continuous and hardworking efforts of physical education teachers, classroom teachers, administrators, food service workers and the Wellness Committee, who have worked collectively to create a healthy and active school environment.

Approval of Minutes

On motion of Trustee Berliner and seconded by Trustee Ludmar and all in favor, the minutes of September 22, 2016 were approved as amended.

Superintendent Report

Dr. Melnick did not give a superintendent report as he will be giving a report on student achievement.

Update on Superintendent Search

Vice-president Jones updated the public on the search for a new superintendent. The second community forum was held on September 29. There is online survey which can be accessed through a

link on the district website. The survey, which will be open until October 15, will inform the Board on what the community is looking for in a new superintendent. The board encourages everyone to complete a survey before the closing date.

Report from the SGO

The SGO representatives were not present at the meeting.

Regular Business Kindergarten Day

Carol Smyth, Elementary Director of STEAM & Linda Burgos, Kindergarten teacher gave a presentation on the kindergarten day and how the district's Shared Valued Outcomes and Common Core Learning Standards are incorporated into the instructional day. Linda Burgos gave an overview of "Purposeful Play" and how she has brought that model of instruction into her classroom. She explained how she is able to use it for interdisciplinary teaching and how it aligns with the district's Shared Valued Outcomes & Common Core Learning Standards; through a student driven class project it has even stretched across grade levels.

The board had a brief discussion. A point was raised that parents are concerned there is not enough recess time. Trustee Ludmar asked how the role of purposeful play is translated from building to building. Ms. Smyth responded, many teachers are involved in the "Purposeful Play Collegial Circle" and there are commonalities in the curriculum and differences in the way it is presented, however individual student needs are being met. She also noted play is incorporated into the school day. Dr. Melnick added, it may look different for each teacher and student but we make sure that every student gets to the same place at the end.

Report on Student Achievement

Dr. Melnick reviewed the New York State test scores for 2015-2016. Overall students scored at or close to 100% passing in all areas. Of particular note Dr. Melnick reported that approximately 90% of students who took the NYS English Regents Exam scored in the mastery range (85% or above)and over a three year period the mastery rate has risen from 70% to 90% which indicates the impact that our work in the area of writing and reading has had. Dr. Melnick associated this remarkable accomplishment to the kind of instruction that has evolved at the high school since beginning the IB exploration process. On the Algebra Regents he reported that in one year the mastery rate went from 20% to 51%. Dr. Melnick reviewed Advanced Placement scores, SAT scores, and the participation rate of students in the IB program. He also noted that the number of our students accepted to the most highly, and highly competitive colleges has risen over the last couple of years.

The board discussed the report. Trustee Russo noted that the increase in mastery on the Algebra Regents does not include the trigonometry portion as that was pushed into Geometry this year. She asked if we are making sure that those students are getting the support they need on the trigonometry portion. Trustee Russo requested that the AP US History course be reinstated in the junior year. She said this was the only AP course taken by many learning disabled students and feels it is a good option for special education students especially considering our goal of equity. Mr. Cousins responded students were prepared for the common core which is why they did so well. There is a plan for transition and there is a trigonometry strand that goes through all of the years including Algebra 1, Geometry, and Precalculus. He also added the number of students subscribing to calculus AB is doubled. He then explained there has been curriculum work in the 11th grade math courses (Precalculus, and both IB Math courses) to ensure the trigonometry topics necessary for advanced math study in 12th grade are covered. Mr. Cousins noted that many special education students took the IB course History of the Americas and those students did very well. The participation rates in IB History and

AP History in prior years was similar. He went on to say that historically, the AP US exam was the AP exam on which students underperformed compared to national averages and compared to other AP exams offered by the school. He summarized by restating that the AP exam requires different types of memorization and recall compared to a more open-ended style of assessment on IB exams and would monitor the performance of the special education students in the IB History course who will sit for the first administration of the exam in May 2017. Trustee Gonzalez noted it is critical not to disregard the 3-8 scores even though the refusal rate was high. She went on to say there is data that can used such as the difference between boys & girls, and kids with disabilities. Trustee Berliner said he would like the report to include goals for our students and areas for enhancing the instructional program, also a study on the percentage of graduates who graduate from college in 4 years and in 6 years.

Comments from the Public

Cheryl Brown, Glen Head, read a statement in regard to the athletic attendance policy and the fact that her daughter was suspended from the soccer team because she was on a family trip and missed the first week of practice. She asked that the board reconsider the athletic attendance policy in the future, although it would not benefit her daughter.

Andrea Macari, Glen Head, asked the board to review the homework policy. She said her kindergarten child gets between 60-90 minutes of homework a night and the homework is uninspiring and of poor quality. Dr. Melnick responded, if a kindergarten student is spending more than 10 minutes a night on homework the parent should get in touch with the principal.

Tim Madden, Sea Cliff, asked if the board looked back at the minutes where they discussed the athletic attendance policy to confirm that there was definitely a decision about academic field trips being on the list of "unexcused absences". President Labbate responded the board did go back over the minutes and found that they decided to uphold the athletic policy committee's decision to keep their attendance policy as is, which does designate trips and academic field trips as unexcused absences. Mr. Madden further noted that Manhasset & Garden City School Districts do not have similar policies. Dr. Melnick responded this is not a board policy it is an athletic policy, which was the result of their two committees comprised of parents, students, and board members. He said there was overwhelming demand on those committees to keep the current attendance policy.

Mr. Madden asked if there has been any progress on negotiations regarding the expired teachers' contract. Dr. Melnick responded he is unable to comment on specifics of negotiations in public but he would say that both parties are negotiating in good faith.
