North Shore Schools Board of Education Regular Meeting Minutes April 20, 2017

The meeting was called to order by President Antoinette Labbate at 6:30 p.m. in the High School Library. Present were Trustees Berliner, Gonzalez, Jones, Ludmar and Russo. Trustee Commander was absent from executive session. Also present Superintendent Dr. Edward Melnick, and Assistant Superintendents Olivia Buatsi & Rob Chlebicki.

At 6:30 p.m. on motion of Trustee Gonzalez and seconded by Trustee Ludmar and all in favor, the Board moved to convene an executive session in room H4 in the high school to discuss matters regarding collective negotiations.

At 7:00 p.m. on motion of Trustee Jones and seconded by Trustee Russo and all in favor, the Board moved to come out of executive session and convened a meeting of the Audit Committee in the library. Trustee Commander arrived at 7:15 p.m.

At 7:50 p.m. on motion of Trustee Berliner and seconded by Trustee Gonzalez and all in favor, the Board moved to adjourn the audit committee meeting and resumed the regular meeting in the library. There were approximately 20 members in the audience.

Pledge of Allegiance

President Labbate led the audience in the Pledge of Allegiance.

Student Recognition

On behalf of the Board of Education, President Labbate and Dr. Melnick recognized students Greg Cantwell & Matt Travaglia for receiving awards at Long Island History Day held at Hofstra University.

Prior to approving the minutes, Trustee Russo said although she did not attend the meeting of April 6 she did watch the video and asked to make a comment. She commented on Dr. Melnick's Superintendent Report regarding college acceptances to highly competitive schools and the correlation he made to how that relates to the implementation of IB. Mr. Chlebicki added with all the concerns expressed that IB might hurt kids entrance to college, the statistics clearly showed this did not happen.

Approval of Minutes

On motion of Trustee Berliner and seconded by Trustee Commander with Trustees Berliner, Commander, Gonzalez, Jones, Labbate and Ludmar for and Trustee Russo abstaining, the minutes of April 6, 2017 were approved.

Report of the Superintendent

Dr. Melnick reported on a Viking Foundation event for incoming Kindergarten parents at the Sea Cliff Yacht Club which was well attended; new parents had the opportunity to meet the elementary principals, some of the kindergarten teachers, and Dr. Giarrizzo. He reminded the public that Meet the Candidates night is next Tuesday, April 25 at 8:00 P.M. in the HS café. He also reminded the public that the celebration of student work, Election of Trustees and Vote on the Budget will take place on Tuesday,

May 16. The budget to budget increase is 2.6% the amount to be collected in school property taxes is actually about \$9,000 less than last year. In addition to the budget proposition, there will be a referendum on the ballot requesting permission to provide transportation to 7th and 8th graders who live one mile or more from the middle school. Approval of this proposition would result in the same one-mile limit for 6-8th grade, and would not involve any additional expenditure of funds. Finally, Dr. Melnick reported that the spring concert season begins next week with the high school choral concert on April 24 and the high school spring concert 1 on April 27.

Report from the SGO

SGO co-president, Frankie Conklin, reported on events and activities at the high school including, a fundraiser volleyball game on April 26 with 15 teachers competing with students; all profits will go to the SGO Relay for Life team. The tape the teacher to wall fundraiser is progressing, those profits will also go to the SGO Relay for Life team. Finally, she reported SGO elections are coming up.

Regular Business

Social Studies Review

Devra Small, Director of Elementary Humanities, Seth Gordon, 6-8 Humanities Teacher Leader and Jim Mendonis 9-12 Humanities Teacher Leader explained the modifications to the social studies program after reviewing the curriculum, assessments, learning expectations and instructional practices through the lens of the new State standards. Although conceptual based learning is not a new shift at North Shore it is a shift at the State level. Curriculum maps were reviewed and examples of student work was shared. It was reported that next year's Global History Regents will cover only the 10th grade curriculum and beginning 2019 the new State assessments will be aligned with the new State standards.

The Board discussed the changes to the Regents exams. Mr. Mendonis explained that next year (2018) students will take a transitional regents exam and in 2019 the new format will be introduced, however districts will have a choice to offer the new exam or the transitional exam in 2019 and 2020; he stressed either way our students will be prepared. He also explained that the cut scores will change. Dr. Melnick added there is some discussion about moving from a number grade to an AP type score of 1-5 or 1-7. Trustee Russo commented on the collaboration on all 3 levels and the importance of all students being at the same level when leaving their home school. Mr. Chlebicki added there is a lot of articulation work going on within the department and the result is how well students K-12 are doing.

Update On Health & Athletic Review

Don Lang, Director of Health, Physical Education & Athletics, along with members of the faculty, spoke about the review and updates to the curriculum including topics of substance use and abuse as well as personal loss. As part of the review, educators focused on when, where, how and what is taught with regard to "decision-making" particularly related to making choices that pertain to drugs and alcohol use/abuse and the resulting consequences of those choices. From this study, the health department has proposed an elective course related to topics that plague adolescents, teens, and young adults.

The Board discussed the report. Trustee Commander felt it is important to deliver this information at an earlier age and to be repeated each and every year. Dr. Melnick explained it needs to be woven into the curriculum as an integrated approach. Mr. Zublionis added, in the broader concept the psychologist and social workers are pushing into classrooms to discuss good decision making in the primary level. Kids are learning they have control over their own decisions.

Mr. Lang then reviewed the updated action plan from the Athletic Review. There were a number of individual and team honors; 16 varsity and 12 junior varsity athletes challenged up from the middle school to the high school; North Shore had 12 Scholar Athlete Teams for the Fall and Winter Seasons (75% of the team must have a 90% or above GPA); The Captains Council has had workshops on

hazing and bullying; The Athletic Policy Committee discussed communication and the attendance policy (changes to the attendance policy will be made); The Booster Club is donating a new score board (membership is a struggle); college handbooks are being updated; mandatory parent meetings are scheduled prior to each season; nutrition speakers have been brought in; and the weight room has been renovated and the kids are using it.

The Board discussed the report. President Labbate said she was surprised with how many students qualified to challenge up considering the new state regulations. She asked how it affects the individual student and the rest of the team and whether there is concern that 13 year olds are playing with 14-17 year olds. Mr. Lang responded it actually gets middle school students to transition better to high school. He also explained that 3 of the teams that the middle school students challenged up to (Swimming, Tennis, Cheerleading) are not offered at the middle school level. Dr. Melnick asked if something is in place to monitor the athlete's adjustment and impact on their overall performance. Mr. Lang responded, we make sure it is a fit and most of the kids who challenge up play all through high school and through college. He further stated, if these kids stay at the middle school they will dominate at the middle school level. Trustee Commander asked if the high school kids resent the middle school kids. Mr. Lang responded, just the opposite, they take the younger kids under their wing and mentor them. He noted they are not putting kids up to fill roster spots, they are moving them up to give them an opportunity to compete at their level. Dr. Melnick noted that the Board can make a decision not to subscribe to self-selection if they wish to revisit this policy.

Trustee Ludmar noted although there is great support from students and parents at our athletic events, there seems to be a lack of sportsmanship from some of our fans. Mr. Lang said this has been an issue and we have increased our supervision budget. He further stated it is a countywide issue and perhaps it is something to integrate into the general physical education class.

Trustee Jones asked for more information on the protocol of students speaking to the Captain about hazing and bullying. Mr. Lang explained that sometimes kids are afraid to speak to the coach so the idea is to build the trust in the captain as the first person to go to with this type of issue. Dr. Melnick added they did try to set up a mechanism to bring up something anonymously, but that did not work either.

Trustee Commander asked about the issue of the Female Triad Athlete which she has previously asked be a focus separate from nutrition. Mr. Lang explained they did bring in a speaker, but she did not go into that issue enough. He said adjustments will be made to that area as they go forward.

Trustee Gonzalez noted what goes on at the high school level can drive what goes on in the middle and elementary level. She suggested the approach of mindfulness and growth mindset that is a focus at the elementary level be pushed more into the middle and high school level to address the issues of anxiety and stress at that level.

Comments from the Public

Paul Eschausse, Glen Head, said he believes people in the community feel the election in May of 2014 was tainted due to a candidate having access to the district's ROBO call system. Mr. Eschausse also alleged that the calls regarding the vote that year went out one after another, one from the district and then from the candidate. He asked that this campaign be run on honesty and integrity. Dr. Melnick responded that no candidate for the Board has ever accessed the district's ROBO call system. Three candidates in previous elections sent out ROBO calls as private citizens by purchasing a list on their own. The order in which calls went out during the May 2014 election was a coincidence. Trustee Commander responded that she did not use the district's ROBO call list and her apology at the time was because a member of the Middle School PTO was being blamed for the incident. She adamantly disagreed with Mr. Eschausse's conjecture of the situation and pledged that honesty and integrity will be used in this election as it was in the last campaign she ran. President Labbate said while the board accepts Mr.

Eschausse's comments, she is distressed that he would attack a member of the board who has worked tirelessly these past 3 years, along with her fellow Trustees, for the community and students of the district. Trustee Gonzalez added, she feels she and Mr. Eschausse have a different definition of mindfulness and she would be happy to have a discussion with him at a later time.

Tim Madden, Sea Cliff, asked about lab periods for next year. He also asked how the elementary social studies curriculum is set; there does not seem to be a chronology. Mr. Mendonis responded lab periods are set up to make it easier for kids to take electives. Dr. Melnick added he will get back to Mr. Madden with more information after consulting with Mr. Cousins. Ms. Small explained that the State divided the topics in the elementary level this year into a more concept based approach with US History being part of the fifth grade curriculum. Finally, Mr. Madden asked if the athletic policy review committee and attendance policy would be excusing academic trips, for example the recent trip to the Galapagos Islands. Dr. Melnick responded that is being looked at.

Rob Mazzella, Glen Head, confirmed that next year will be the first year the Regents will be based on 10th grade curriculum only. He then encouraged everyone to attend Meet the Candidates Night. He thanked all those running for the Board, thanked Trustee Gonzalez for her 3 years of service and suggested that the candidates give the community a last minutes Q&A opportunity prior to the vote.

On motion of Trustee Russo and seconded by Trustee Ludmar, with Trustees Berliner, Commander, Gonzalez, Jones, Labbate and Ludmar for and Trustee Russo abstaining, it was: <u>Adoption of Revised Policy Regulation #5405-R (Wellness)</u> Resolved: That the board adopt revised Wellness policy regulation #5405-R as discussed at the meeting of April 6, 2017, effective April 20, 2017

Comments from the Public

There were no comments from the public.

Old Business

President Labbate asked to confirm the terms for the two community Audit Committee Members, Ray Ottusch and Bob Morales.

Trustee Ludmar noted that at a previous meeting a public comment was made that IB was implemented without knowledge of the Board. He asked Dr. Melnick to supply any information in this regard to correct public perception. Dr. Melnick gave a timeline and summary of the 25 meetings in which IB was discussed by the Board from October, 2012 through March, 2017.

Trustee Russo noted there was a comment from a member of the community from the last meeting who said she was happy with the direction the Board was taking with regard to IB. She went on to say it is harder when someone does not agree with the Board, but she does not feel there was ill intent in the comment from the resident who spoke at the prior meeting. She felt the point of that commentary was for more offerings of AP courses, not for the elimination of IB. She noted there has

been some comments on social media about this. She said the board should encourage the community to make their comments directly to the Board and not on social media.

Trustee Gonzalez suggested a policy of designating a Trustee to report on correspondence to the Board from community members. President Labbate suggested this be discussed more fully at a later time.

Trustee Russo noted the LAC flyer needs approval so can be mailed out and meet deadlines.

New Business

Trustee Russo emailed a letter that SuperLAC would like to send to Commissioner Elia. The letter addresses three topics; changing ELL requirements, reducing the number of days that assessments are given, and changing reporting time to SED. She asked to amend the agenda to add it as a discussion item.

On motion of Trustee Russo and seconded by Trustee Labbate and all in favor, a discussion on the SuperLAC Letter to Commissioner Elia was added to the agenda.

Trustee Berliner noted that the letter does not state our top priorities first. He asked if a statement could be added that the list is not in priority order. Trustee Russo asked for any additional comments be emailed to her for inclusion in the letter before the next meeting. The letter will be placed on the next agenda for approval.

President Labbate reported that a community member asked whether or not the Board is interested in discussing a change in policy regarding suspected drugs in the high school, specifically random drug testing and bringing in drug sniffing dogs to the school. She asked if there is any interest on the Board to have this on a future agenda as a discussion item. Dr. Melnick suggested it be a larger discussion about a change in culture and that it include the high school administration, parents, and students. The Board decided to wait until Dr. Giarrizzo can be part of the discussion.
