The meeting was called to order by Superintendent Dr. Christopher Zublionis at 6:30 p.m. in the Middle School Cafeteria. Present were Trustees Cashman, Galati, Ludmar, Macari, Mosca and Svendsen. Trustees Colacioppo was absent. Also present were Assistant Superintendents Dr. Carol Smyth and Mr. James Pappas.

At 6:30 p.m. on motion of Trustee Macari and seconded by Trustee Cashman and all in favor, the Board convened an executive session in the faculty lounge to consider matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or persons, and proposed, pending or current litigation.

At 7:55 p.m. on motion of Trustee Galati and seconded by Trustee Mosca and all in favor, the Board came out of executive session and resumed the meeting in the cafeteria. There were 5 people in the audience.

Pledge of Allegiance

Superintendent Zublionis led the public in the pledge of allegiance.

Election of Board Officers

The floor was opened to nominations for Board President.

Trustee Richard Galati nominated Trustee Andrea Macari for President of the Board. Trustee David Ludmar seconded the nomination.

With no other nominations put forth, a vote was taken and by unanimous vote it was: RESOLVED: To approve the election of Andrea Macari as Board President for the fiscal year July 1, 2024 through June 30, 2025.

Trustee Andrea Macari was sworn in as President of the Board of Education by the District Clerk.

The floor was opened to nominations for Board Vice-President.

Trustee Maria Mosca nominated Trustee Lisa Colacioppo for Vice-President. Trustee David Ludmar seconded the nomination.

President Macari noted that Trustee Colacioppo was not present but indicated to her that if nominated, she would accept the nomination.

With no other nominations put forth, a vote was taken and by unanimous decision, it was: RESOLVED: To approve the election of Lisa Colacioppo as Vice-President of the Board of Education for the fiscal year July 1, 2024 through June 30, 2025.

Trustee Lisa Colacioppo will be sworn in as Vice-President of the Board of Education by the District Clerk at her earliest availability, prior to the next scheduled board meeting.

Dave Ludmar noted how much more there is to do for a member of the Board who is serving as an officer, and he thanked both Trustees Macari and Colacioppo for volunteering to serve another year as Board President and Vice-President.

President Macari thanked Trustee Galati for the kind words in his nomination speech and her fellow Trustees for voting her in as president for another year. She spoke of her first year as president and the challenges she faced. She said as the year progressed, her one overarching goal was for the board to function as a united team with peace, cooperation, civility and kindness. She noted it is often difficult for 7 people with differing experiences and priorities to achieve harmony when doing so much painstakingly detailed and important work. She went on to say she believes this board has shifted over the last 12 months and this has produced a shift in the community as evidenced by the number of voters who came out to support this year's budget. President Macari said the work is never done, they are doing meaningful work, there is a lot to accomplish this year, and she cannot imagine doing it with any other people.

Resolution for Appointing Impartial Hearing Officers

WHEREAS, a Board of Education is required by Section 200.5 of the Regulations of the Commissioner of Education to initiate the process for selecting an impartial hearing officer by no later than two (2) business days after receipt by the school district of a written request for hearing by a parent or guardian of a disabled student; and

WHEREAS, the Commissioner's Regulations specifically authorize a board of education to designate one or more of its members to appoint an impartial hearing officer in lieu of action by the full board in order to meet the timelines of the amended Regulations;

BE IT RESOLVED, that the President of the Board of Education, or on the occasion of his or her absence or inability, the Vice President of the Board of Education, is hereby authorized and directed to appoint an impartial hearing officer from the District's alphabetical rotational list previously adopted by the Board of Education; and be it further

RESOLVED, that the President of the Board of Education, or on the occasion of his or her absence or inability, the Vice President of the Board of Education, shall make such appointment in accordance with the principles set forth in Section 200.5 of the Regulations of the Commissioner of Education. The District Clerk, or his or her designee, under the direction of the President of the Board, shall initiate the selection process by contacting the impartial hearing officer who last served, and shall canvass the list as provided in the Regulations until an appointment is accepted.

Regular Meeting- 8:18 p.m. District Wide Safety Plan Public Hearing

District-wide school safety plans and building-level emergency response plans are designed to prevent or minimize the effects of violent incidents and emergencies and to facilitate the coordination of schools and school districts with local and county resources in the event of such incidents or emergencies. Education Law 2801-a and Commissioner's Regulation 155.17 require schools and districts to create a number of different safety teams, including the District-wide School Safety Team. The North Shore School District Safety Team, which includes representatives of the school board, staff, faculty, administrators and parents, has the responsibility of reviewing and updating as necessary the district's safety plan on an annual basis.

The District is required to hold a public hearing that provides for school personnel, students, and public participation, and must be made available for public comment at least 30 days prior to the hearing. The North Shore School District's Safety Team reviewed and updated the DW Safety Plan at their May 12, 2024 District-wide safety meeting. The 30 day "Notice of Public Hearing" was

published in the local newspapers on May 23, 2024. The DW Safety Plan was made available for review by the public on the district webpage and at Central Office.

President Macari opened the floor for comments. With no comments, President Macari closed the public hearing.

Prior to approval, Trustee Mosca noted that while she is no longer on the Districtwide Safety Committee, she is aware of the great work that the committee does. She commended Mr. James Glennon and the committee for their efforts that went into the Safety and Emergency Management Plan.

On motion of Trustee Galati and seconded by Trustee Cashman and all in favor, it was: Approval of the District Wide Safety & Emergency Management Plan

BE IT RESOLVED, That the Board of Education of the North Shore Central School District hereby approves the 2024-2025 District-Wide Safety and Emergency Management Plan as reviewed by the District-wide Safety Team

Approval of Minutes

The reading of the draft minutes of the meeting of June 13, 2024, being prepared and disseminated to all members in advance of the meeting, were dispensed. There being no corrections to the minutes, it was declared by President Macari that the minutes of the meeting of June 13, 2024 were approved.

Prior to approval, Trustee Ludmar noted that there is sometimes confusion between the budget vote and the tax levy. He explained this is a two-step process required by law. He further explained that the budget is an estimate of the tax impact. Setting the tax levy is part two of the process something the Board does every year.

Report of the Superintendent – 8:20 p.m.

Dr. Zublionis reported that all of the moving on ceremonies and the high school graduation ceremony were very successful. He thanked all for the preparation for those ceremonies and said they are continuing to think about how to hold those ceremonies in the future. He remarked that the highlight for him was the graduate walk, when seniors go back to their elementary school. He noted that former Glen Head Principal, Lori Nimmo attended the graduate walk at Glen Head School and she also attended the High School commencement ceremony. Dr. Zublionis congratulated the Class of 2024 and said it is his hope that all the graduates "discover their dreams" post North Shore High School.

Dr. Zublionis reported that they have received the Regents and AP test scores; students did very well. They are disaggregating the information and will get that information to the Board. The summer at North Shore is very busy with professional development, TENs enrichment program, a new Robotics program with Mr. Peroni and the Extended School Year (ESY) program.

Dr. Zublionis reported that some of the buildings experienced a water outage due to the road construction. He thanked the contractors for moving the start date of the constructions until after schools were closed.

Dr. Zublionis reported on the Administrators' 2-day retreat. The second day was offsite at a BOCES center where they worked on goals, team building and navigating technology and Al. They are working on a technology white paper and looking at the code of conduct, and Parent Universities to come up to speed with Al.

Dr. Zublionis thanked the buildings and grounds, cleaning and maintenance crews who are working hard to get the buildings ready for September.

Finally, Dr. Zublionis gave the schedule for fall sports which will begin in mid-late August, grade 6 (8/27) and 9 (8/28) orientation and supply pick-ups, Superintendent's Conference Day (8/29) and first day of school in September (9/3). He noted that offices are open all summer if parents have any questions.

Trustee Galati noted that the Board has discussed receiving regular updates from their lobbying firm. He asked if a request could be made to receive information from them on a more regular basis, possibly a formalized schedule. Dr. Zublionis explained that their work is seasonal, based on the schedule in Albany, however he will ask them to send updates on a more regular basis. Trustee Mosca added a monthly Newsletter, similar to what is sent by NYSSBA, with information on what they are lobbying for, or what counsel is working on, would be helpful.

President Macari asked if there is any information from Frazer Feldman, on developing training processes for people who serve on committees, possibly an online model. She also asked that as student schedules are looked at for next year, that recess time at the elementary level is tweaked a bit for more play time.

New Business

Trustee Ludmar asked for an update on SED's plans to overhaul the Regents exams and diploma requirements.

Trustee Mosca asked if the road construction, currently blocking the back parking lot of the high school, will be done before school begins. Dr. Zublionis explained that Legislator DeRiggi-Whitton is responsible for getting this construction on Glen Cove Avenue done for better drainage on our roads. The construction was scheduled to begin the day of graduation, however Dr. Zublionis was able to speak to someone at the county who moved the start date. It is scheduled to be done before school begins. Trustee Ludmar asked if our contractors will have access to our buildings during the parking lot closures. Dr. Zublionis believes there will be access to the buildings but will confirm that.

Trustee Cashman wondered if during this quiet time in the summer, our lobbying firm can give us some strategies for the tax implications that are on the horizon. She also would like the Board to start to consider planning for a capital reserve. Dr. Zublionis explained they are already planning a long-term strategy. He also noted that the discussion on buildings and grounds was postponed but will be presented in the fall.

Trustee Mosca asked that the EPC be included in the presentation on buildings and grounds. Mr. Pappas explained that he has spoken with the EPC company and he is hoping they will be available for a presentation at the beginning of the year.

President Macari noted that Dr. Smyth and Ms. Aguiar-Mady wrote an amazing grant which will benefit ELL students. Dr. Smyth added Mr. Doherty also assisted in the writing of that grant. They are waiting to hear if they have been awarded the grant.

Dr. Zublionis reported that they may need to have a brief mid-summer business Board meeting for personnel appointments.
