Minutes  
July 26, 2024

The meeting was called to order by President Andrea Macari at 9:00 a.m. in the Central Administration Conference Room. Present were Trustees Cashman, Colacioppo, Ludmar, Mosca and Svendsen. Trustee Galati was absent. Also present were Superintendent Dr. Christopher Zublionis and Assistant Superintendents Dr. Carol Smyth and Mr. James Pappas.

At 9:02 a.m. on motion of Trustee Colacioppo and seconded by Trustee Cashman and all in favor, the Board convened an executive session in the conference room to consider matters leading to the employment or appointment of a particular person or persons and proposed, pending or current litigation.

At 9:42 a.m. on motion of Trustee Ludmar and seconded by Trustee Mosca and all in favor, the Board came out of executive session and resumed the special meeting. There was no public present at the meeting.
