NOTE: All Transportation Requests must be submitted in person at the Transportation Department by April 1, 2019 or sent by CERTIFIED MAIL
POSTMARKED ON or BEFORE APRIL 1, 2019. Failure to submit this transportation request form on or before April 1, 2019 may result in your child being ineligible for district transportation for the 2019-20 school year. In this case, the cost and the arrangement for transportation will be parental responsibility. In accordance with New York State Education Law, transportation requests received after the above date will not be accepted unless a reasonable explanation is given for the delay or the District can provide the transportation under existing arrangements without additional expense. A belated decision to enroll a student into school is not a reasonable explanation for late submission of a transportation request. Those students who move into the District after the expiration of the deadline can still submit a written request for transportation provided such request is made within thirty (30) days after establishing residence in the district.
